2023 Capital Planning <u>CONSIDERATIONS</u>

2023 Challenges – COLA – 6-7% affecting purchases, wages, & most budget items. Supply chain issues, delays in delivery, shortages of contractors and short ability to prepare for increases.

2023 Revenues – Need to maximize the use of reserves and grants to keep property tax increases to a reasonable amount for capital.

2023-2026 Multi-Year Budget – Implement multi-year budgeting based on AMP and condition assessments to address strategic Council priorities and financial sustainability for the long-term.

AMP - Prepare for Asset Retirement Obligations (ARO) and next phase Asset Management requirements.

Future Need – The budget will emphasizes the relationship between expected service levels and the costs required to provide them.



2023 Capital Budget <u>OVERVIEW</u>

- 2021 operating surplus was \$1,385,326 and Water & Wastewater surplus was \$984,314 = \$2,369,640.
- Deficit/Surplus Policy
 - \$554,130 went to general capital and \$138,533 went to tax rate stabilization and \$692,633 remained as operating funds.
 - \$728,236 went to water and wastewater capital and \$246,079 went to water rate stabilization.
- 2023 Capital Budget proposes \$264,000 from taxation, \$957,000 from reserves and \$405,000 from other to fund <u>new recommended</u> = \$1,626,000
- Combined with previously committed, total 2023 capital = \$5,019,716

• 2023 Cost: \$200,000

- To meet accessibility requirements and redesign workspace incl. library expansion and chair lift.
- \$200,000 from reserves.
- Request for Quotations by June 2023.
- Goal is to begin construction pending funding in 2024-2025.

- Update Asset Management Plan with data on buildings including building componentization
- To develop a condition assessment strategy for asset management
- To maximize grant available to undertake condition assessments of all buildings – FIREHALL.

COST: **\$62,500**

- \$50,000 is funded by the FCM Grant, \$12,500 from taxation
- If approved, complete By December 2023.

- Track replacement will be 4 lane 400m track using crushed rock
- Features a base of gravel for improved drainage
- COST: \$130,000
- FUNDED: Trillium Grant 100% FUNDED \$130,000
- **TIMELINE:** To be completed September 15, 2023
- PROJECT GOAL/OUTCOME:
 - Replacement of running track allows us to maintain service levels
- SHORT & LONG-TERM BENEFIT:
 - Short Term: Safe and accessible outdoor recreation
 - Long Term: Reduced maintenance costs and time, sustainable hosting of events

2023 CAPITAL PROJECT Community Fire Risk Assessment



- COST: \$25,000
- **FUNDED:** Reserves (Raised from Taxation in 2022)
- TIMELINE: 2023
- PROJECT GOAL/OUTCOME: To complete an assessment identifying, analyzing, evaluating and prioritizing risks to public safety.
- SHORT & LONG-TERM BENEFIT: Assist in making informed decisions about the provision of fire protective services.

O. Reg. 378/18: COMMUNITY RISK ASSESSMENTS under Fire Protection and Prevention Act, 1997, S.O. 1997, c. 4

- comes into effect on July 1, 2019
- municipalities have 5 years from that date to do their risk assessment (must be done by July 1, 2024)
- must complete a new risk assessment every 5
 years after the date the first on was completed
- must review the risk assessment within 12 months from completed risk assessment or date of last review

PROJECT GOAL/OUTCOME:

- Continued supply of safe drinking water
- Asset life increased 25+ years



2023 – 2026 CAPITAL PROJECT Hydrant Rehabilitation

COST: \$45,000.00 per year

• To be funded from Water and Wastewater Revenues

TIMELINE:

• Ongoing

PROJECT GOAL/OUTCOME:

- Cost effective method by which to rehabilitate rather than replace Fire Hydrants
- Increases the life cycle of municipal assets and ensures the ongoing supply of water for fire protection.



2021-23 CAPITAL PROJECT Sewer Jet/ Vacuum Trailer

COST: \$90,000.00


• To be funded from Water and Sewer User Fees over four years

TIMELINE:

• Complete By October 31, 2023

PROJECT GOAL/OUTCOME:

- Purchase equipment for blocked laterals, staff response time faster to resolve blockages.
- Reduces operating budget by \$20,000.00 to \$30,000.00 annually.
- Increases services provided, reduce operating budget costs, faster response time for blocked laterals.





2022 - 2024 CAPITAL PROJECT Water Treatment Plant Filters

COST: \$550,000.00

• To be funded from a combination of Water and Wastewater User Fees and reserves over three years beginning in 2022

TIMELINE:

Complete By December 31, 2024

PROJECT GOAL/OUTCOME:

Installation of new water filters



 Increases the life cycle of municipal assets and ensures the ongoing supply of safe drinking water

<u>Note</u>: This project has been negatively impacted by supply chain issues



2007 - 2023 CAPITAL PROJECT Landfill Expansion

PROJECT DESCRIPTION

• This project will extend the use of current landfill site by addition of a new cell which will extend the asset for 25+ years providing a location to dispose of solid non-hazardous waste.

PRIORITY RANKING – HIGH PRIORITY

 Project is ongoing, initial review started in 2012. Funding received from both Federal and Provincial to complete this project in 2021 with 66.66% funding from Small Communities Fund (SCF).

2007 - 2023 CAPITAL PROJECT Landfill Expansion

<u>COST:</u> 2021/22 - \$1,627,778 (2016 to 2022)

2023 - \$400,000


• To be funded from Reserve Funds

TIMELINE

• Completed by December 31, 2024

PROJECT GOAL/OUTCOME

• Extends landfill use to 25+ years with addition of new cell and reconfigures the existing site layout for easier accessibility and disposal. Continue to service residents while reducing costs of hauling waste to another site.





2021-2026 CAPITAL PROJECT Sidewalk Rehabilitation

PROJECT DESCRIPTION

This project will replace our sidewalks over time on a highest to lowest priority rating. The 2021 Streetscan project assisted in identifying the priority areas.

PRIORITY RANKING – HIGH PRIORITY

Project is ongoing, initial replacement started in 2021 with the receipt of funding which will be fully consumed by the end of 2024. The program will continue through 2026 by accessing reserves.

2021-2026 CAPITAL PROJECT Sidewalk Rehabilitation

<u>COST:</u> 2021 to 2026 - \$171,000

- \$58,000 to be funded from grant in 2023 and 2024
- \$70,000 from Reserves in 2024 and 2025

TIMELINE

• Ongoing

PROJECT GOAL/OUTCOME

- The goal is to replace broken, unsafe sidewalks
- Reducing potential hazards and claims



2021-2026 CAPITAL PROJECT Pavement Preservation

PROJECT DESCRIPTION

• This project will address pavement concerns over time on a highest to lowest priority rating. The 2021 Streetscan project assisted in identifying the priority areas.

PRIORITY RANKING – HIGH PRIORITY

 Project is ongoing, initial rehabilitation began in 2022 with a section of Regina Avenue. The program will continue through 2026.

<u>COST:</u> 2022 to 2025 - \$600,000

\$150,000 per year to be funded from a combination of Taxation and Reserves.



2023- 2026 CAPITAL PROJECT Airport Terminal Building

• <u>COST:</u> 2023 to 2026 - \$150,000

 \$150,000 over three years to be funded from a combination of Taxation, Reserves and donations

•<u>TIMELINE</u>

2023 to 2026

• PROJECT GOAL/OUTCOME

- To replace equipment that has reached the end of its useful life to ensure runway and airport safety.
- To improve energy efficiencies and accessibility at the airport terminal.



PROJECT DESCRIPTION

- These are smaller projects with the goal of increasing the useful life of the associated assets.
 - IS Building Magpie Replace heating system
 - Mower replace aging mowers in 2026
 - Compressor Water Treatment Plant
 - Lower Lift Station IT Upgrade
 - Chlorinator Pump Water Tower

PRIORITY RANKING – HIGH PRIORITY

 These projects will either replace small assets which are past their useful life or upgrade larger assets in order to extend the useful life of the asset

• <u>COST: 2023</u> to 2026 - \$55,000

- IS Building \$55,000 per year to be funded from a combination of taxation, water fees and reserves.
- Mower \$10,000 to be funded from taxation
- Compressor Water Treatment Plant \$35,000 to be funded from water revenues (2023)
- Lower Lift Station IT Upgrade \$30,000 to be funded from reserves
- Chlorinator Pump Water Tower \$25,000 to be funded from reserves

2023 CAPITAL PROJECT Mini **Excavator** 8 Trailer

PROJECT DESCRIPTION

 This project will improve the services delivered by the IS Department by providing a better tool for works required throughout the year

PRIORITY RANKING – HIGH PRIORITY

- Will assist in reducing the cost of the landfill expansion as it will enable us to complete a large amount of the work internally;
- Will assist with digging burial plots in the cemetery and minimize landscaping damage caused by heavy equipment; and

• Will assist with sidewalk rehabilitation and replacement projects.

2023 CAPITAL PROJECT Truck Water Dept.

PROJECT DESCRIPTION

 This asset will assist the Water Department with being able to provide better day-to-day and on-call services

PRIORITY RANKING – HIGH PRIORITY

 This asset will allow the water department to provide improved water and wastewater services by providing more space for equipment required to respond to emergencies.

2023 CAPITAL PROJECT Water Distribution Upgrade

PROJECT DESCRIPTION

 This project prioritizes upgrading the Municipality's booster pump station to ensure adequate distribution system pressure to meet required fire flows.

PRIORITY RANKING – HIGH PRIORITY

- Identified in SBA Water Master Plan as an immediate concern this project will protect business owners in the Municipality's industrial park; and
- Can assist in facilitating any community expansion efforts in the Pinewood Drive area.

2023 CAPITAL PROJECT **Roll Off** Truck Landfill

PROJECT DESCRIPTION

 This asset is required as part of the landfill expansion to move the refuse collection bins. This will eliminate patron interaction with the active landfill site and improve patron and worker safety.

PRIORITY RANKING – HIGH PRIORITY

 This vehicle will be used to move the refuse collection bin from the refuse receiving area used by landfill patrons to the refuse collection cell at the back of the landfill expansion site.

2023 CAPITAL PROJECT Roll Off Truck - Landfill

COST / TIMELINE:

- \$100,000 will be funded from a combination of taxation and reserves.
- This project will be completed in 2023

PROJECT GOAL/OUTCOME

 To purchase an asset necessary to the operation of the new landfill cell
